We have the following policy guidelines to ensure that we perform the highest quality exam that we can give you and your baby:

- There is a limit of three visitors during all ultrasound exams
- Due to the highly technical nature of your ultrasounds, children must be supervised by an adult during the exam.
- If you bring a CD (not DVD) we will download some images of your baby for safekeeping. We will also try our best to provide a 3D image along with other images whenever possible.
- This is a medical exam and therefore, we do not allow videotaping of any kind during the exam, including cell phones.

Please bring your insurance card and this form with you at the time of your exam. Amounts not covered by insurance and co-payments, are due at the time of service.

A provider will call you in approximately one week with results of your exam.

How to prepare for your Ultrasound:

OB ULTRASOUND

If you are having one of the following types of ultrasounds:

<14 wks Gestation

Nuchal Translucency

Detailed Anatomic Screening

Finish drinking **24 oz** of water or clear juice 1-hour prior to your appointment time. Do not empty your bladder for 1-hour prior to the appointment.

GYN ULTRASOUND

Finish drinking **32 oz** of water or clear juice 1-hour prior to your appointment time. Do not empty your bladder for 1-hour prior to the appointment time.

Directions from our Greece Office

1. Turn RIGHT onto LONG POND ROAD
2. Turn RIGHT onto RIDGEWAY AVE
3. Turn RIGHT onto BELLWOOD DR
4. Take ramp onto 390 South
5. Travel South on 390 to exit 16B-E. Henrietta Road, Route 15A
6. At the third stoplight, turn RIGHT onto WESTFALL Road
7. At the second stoplight, turn LEFT onto S. CLINTON AVE
8. Turn LEFT into Brighton Corners Office Park (approx 1 mile)
9. Veer left into office park. Make first right. Go to end of drive and Suite 610 is in the bldg on the left

Directions from our Webster Office

1. Turn left onto EMPIRE BLVD
2. Merge onto 590 South via the ramp on the left
3. Take ELMWOOD AVE exit-exit number 3
4. Turn RIGHT onto ELMWOOD AVE
5. Turn LEFT onto S. CLINTON AVE
6. First RIGHT is Brighton Corners Office Park
7. Veer left into office park. Make first right. Go to end of drive and Suite 610 is in the bldg on the left
